Frequently Asked Questions

What is ArtJune?

ArtJune is a fine arts and crafts juried art fair held on the lawn of the Sauk County Courthouse in Baraboo, Wisconsin since 1963. We've changed the name and the date over the years, but have always been on the lawn, rain or shine!

What kind of Media is Accepted?

2-D work (paintings, watercolor, photography, etchings, etc.), sculpture, wood working, glass work, pottery & ceramics, jewelry, fiber arts, metal arts are all welcome. Mass produced and/or resale work is not accepted.

What Criteria does the Jury use?

We have four criteria: "will it sell," "delight," "skill," and "uniqueness."

How many artists will there be?

ArtJune is limited to around 50 artists representing a balance between the media.

Who are the Buyers?

Regional residents, tourists to Wisconsin Dells and Devils Lake State Park.

Artist Amenities

- Booth sitters are available for breaks.
- Artist-use-only off-site parking is available.
- "indoor" restrooms
- Artist "breakfast"

Judging

This event is judged. The awards given are Best Portfolio, Best 2-D, Best 3-D and two Judges Choice Awards. While there is no monetary award, our award winners may claim a spot in the next ArtJune without being juried in!

Booths

- The booth fee for accepted artists is \$100. Booth fee checks will be deposited by June 1.
- Each booth is at least 12 ft x 12 ft and is dependent upon the fixtures and plants along the sidewalks.
- There is NO jury fee.

Setup and Take Down

• Unloading and loading assistance for artists may or may not be available. Driving on courthouse sidewalks is not allowed.

Schedule Updates

2020 brings a few changes:

- We have three calls. Early Bird, First Call and Second Call, each with a different booth fee.
- Successful Early Bird Applications, those submissions dated by or on September 31, 2019 will receive a \$10 discount off the cost of the booth for a booth fee of \$90.
- Successful First Call Applications, those submissions received between October 1, 2019 and January 31, 2020, will be charged \$100 for their booth.
- Late Fees of \$25 will be applied to successful applications submitted after February 1, 2020 and before May 15, 2020 for a booth fee of \$125.
- Schedule Detail Recap
 - ⇒ EntryThingy (online) Registration opens by September 1, 2019, remains open until May 15, 2020
 - ⇒ Early Bird Applications received before October 1, 2019 (Early Bird Call, Booth Fee \$90)
 - ⇒ Applications due by January 31, 2020 (First Call, Booth Fee \$100)
 - ⇒ Jury Notification to Early Bird and First Call Applicants by February 20, 2020
 - ⇒ Late Applications due by May 15, 2020 (Second Call, Booth Fee \$125)
 - ⇒ Jury Notification to Second Call Applicants by June 1, 2020)
 - \Rightarrow ArtJune on June 20, 2020
- Submissions will be marked with either a submission date by EntryThingy OR a Postmark by the USPS.

 - ⇒ If you've never used EntryThingy before, BUT you have entered our show in the last couple years, you may have an account. When we add you to our submission list, we need to enter your email address. So start by "recovering" your password.

Images

You will need five images, four of your work and one of your booth. Images should be:

- Digital, the higher the resolution the better, but stay at about 500kb per image.
- Don't print them on paper. Please! We will have to make them digital to go through the jury process. Digital=>paper=>Digital will not do your work justice!

- If you email us images, please name them in such a way that we can connect them to your application.


Payment of Booth Fee
